PROPOSED REGIONAL HOSPITAL

OBJECTIVE

The objective of this project as envisioned by the President is to ensure that Ghanaians in every district and region in the country have access to quality healthcare services.

The proposed project, together with our National Health Insurance Scheme, will boost the provision of healthcare infrastructure and financial accessibility to healthcare, in line with government's commitment to ensuring universal health care to all citizens and attainment of United Nations'

Sustainable Development Goal 3 (SDG3).

It will further be a fulfilment of the government's policy of a hospital in each district and region and improve the geographical coverage of healthcare delivery in the country, as well as offer improved access to healthcare for all Ghanaians. In the process, the outcome will also come with a model of accelerated construction of health facilities developed for future health projects.

SCOPE

The Agenda 111 project will cover the following deliverables: Design, Procure, Construct, Equip and Commission 101 District Hospitals, 6 Regional Hospitals in the newly created regions, as well as 1 Regional Hospital in the Western Region, 2 Psychiatric Hospitals in Kumasi and Tamale and redevelop the Accra Psychiatric Hospital.

There will also be the rehabilitation of the Effia Nkwanta Regional Hospital.

All hospitals shall have a compliment of staff accommodation for Doctors, Nurses and other health workers.

DESIGN ETHOS-DISTRICT HOSPITALS

The AGENDA 111 District Hospitals presents an unparalleled opportunity to transform the country's health care system creating a new standard on the continent. This is the largest healthcare infrastructure project ever undertaken in the history of the country.

Guided by the ambition to define a next-generation hospital experience, the design concept merges 21st century technology with a contextual and holistic approach crucial to the delivery of state-of-the-art healthcare. Central to the design concept is the ambition to reposition the

hospital as a vital piece of community infrastructure that cultivates a sense of place whilst promoting efficiency, comfort and cleanliness. The design concept was borne out of four project pillars establishing a low carbon footprint, a water harvesting system, a solar harvesting system as well as creating thermal mass.

Once implemented these four pillars will set a new precedent for the design and construction industry that leverage's local resources to produce high-performance buildings.





FACILITIES

These modern, fully equipped state-of-the-art District Hospitals, will have facilities for Outpatient services including consultation facilities for medical and surgical cases, Ophthalmology, Dental and Physiotherapy and Imaging services.

Other facilities provided include Maternal and Child Health, Public health, 4 state-of-the art surgical theatres for Maternity, Obstetrics and Gynecology, Accident and Emergency and General Surgery. In addition, the facility will have the full complement of male, female, pediatric and isolation wards.

Provision is made for support facilities that include Kitchen, Laundry, Sterilization, Mortuary, Energy Centre and Maintenance. Each hospital will also come with a compliment of Staff accommodation for doctors, nurses and other health workers.

WORK CARRIED OUT TO DATE

Since May 2020, the Consultants have been working on the technical details for the project. Various consultations have been held with key stakeholders such as the Ministry of Health, Ministry of Finance, Ghana Health Service, Mental Health Authority, Regional Coordinating Councils, District Assemblies, Traditional Authorities and opinion Leaders.

District Assemblies were tasked to provide sites that meet guidelines established by the technical

team visited all available sites. Further, soil tests were undertaken at all the approved locations to determine the suitability for construction works.

Architectural and Engineering Designs, Specifications, Bills of Quantities and Contract Documentation for the District, Psychiatric and the Regional Hospitals are ready for the start of AGENDA 111.
